My dear Doctor,

A careful reading of this article will no doubt suggest to you as it did to me that perhaps the exposure of Medium E to the argon light had something to do with producing some kind of vitamin in Medium X rather than a new action that the light itself might have had on the germs. May I take the liberty of suggesting that rather than expose the germs next time to your light that you prepare a lot of Medium K, after a thorough sterilization, etc. as it is ordinarily prepared, and expose the Medium itself to the light. Later on in this exposed Media, see if you can not grow the same germs and avoid the sacrobic treatment that you subjected them to in the first experiment. Do you get the drift of what I am trying to say?

Please telegraph me as soon as you receive this letter and let me know definitely what we can do.



Recognition of you and your work has been my sim for the last three or four years and it looks like you have built up in your own mind an insurmountable obstacle to that end.

I do hope that in the near future you and I can have a good long heart-to-heart talk about the whole business and come to some reasonable solution to the problem. You now have as perfect a one-man laboratory as anyone could desire but you know you cannot make a reputation out of brick and mortar, because if that were true, the Rockefeller Foundation and Cal Tech would have reputations so high that mobody could approach that. Principles, a compliance with the smenities of life, infinite patience, and a willingness to subject oneself to all kinds of personal inconveniences and worries have been the price that every great research man has had to pay for success. Money and equipment in the past have never produced the great advances that have been made in the world of science.
